Channing Hall will:

2. Hold parent teacher conferences two times each school year during which this compact will be discussed as it relates to the individual child's achievement. Specifically, these conferences will be held:

1st – October 6 and 7

2nd – March 2 and 3

3. Provide parents with frequent reports on their children's progress. Specifically, Channing Hall will provide reports as follows:

Parents receive reports on student progress at student led conference. Parents are welcome to schedule additional conferences if needed. In addition, students are screened for reading difficulties. When a student requires additional instruction, the parent is notified.

4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:

Parents may schedule appointments with staff before or after school hours.

5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

Channing Hall's CHAPS parent organization officially invites and organizes parent volunteer opportunities at back-to school night and throughout the year. Teacher newsletters and Channing Hall's Weekly Howl email explicitly invite parents to volunteer in the classroom every day of the year with approval from the classroom teacher.

Parent Responsibilities

We, as parents, will support our children's learning in the following ways:

- *Ensure that my child attend school regularly;*
- *Monitor homework assignments;*
- *Monitoring amount of television my child watches;*
- *Volunteer in my child's classroom;*
- *Ensure that my child gets proper rest;*
- *Stay informed about my child's education and communicate with Channing Hall by promptly reading all notices from Channing Hall either received by my child, email or by mail and respond as appropriate; and*
